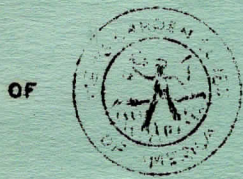

RULES

1. ON ARRIVAL, EXHIBITORS PLEASE REPORT TO THE SHOW COMMITTEE FOR INSTRUCTIONS.
2. ALL ENTRIES MUST BE READY FOR JUDGING BY 11:00 A.M. JUNE 11, 1960. DOORS OPEN TO ALL EXHIBITORS AT 8:00 A.M. DOORS OPEN TO THE PUBLIC AT 3:00 P.M.
3. CONTAINERS, EXCEPT FOR ARRANGEMENTS, WILL BE SUPPLIED.
4. ALL ENTRIES ARE TO BE PLACED FINNALLY BY THE COMMITTEE.
5. THE SPONSORS OF THE SHOW WILL NOT BE RESPONSIBLE FOR THE PROPERTY OF THE EXHIBITORS.
6. ALL EXHIBITS ARE TO BE LEFT INTACT UNTIL 6:00 P.M. SUNDAY, AND REMOVED AS PROMPTLY THEREAFTER AS POSSIBLE.
7. ALL FLOWERS MUST BE GROWN BY EXHIBITORS, EXCEPT IN THE ARRANGEMENT CLASSES.
8. THE DECISION OF THE JUDGES WILL BE FINAL.
9. ALL VARIETIES MUST BE LABELED CORRECTLY WITH NAME AND VARIETY, IF POSSIBLE.
10. ARTIFICIAL MATERIAL CANNOT BE USED IN ANY WAY, SHAPE OR FORM.
11. THIS IS A RIBBON SHOW, ALL ENTRIES BEING JUDGED AGAINST PERFECTION.

CLASS 2 VASE OF 6, 1 VARIETY OR MIXED, 3 VASE LIMIT.

SECTION B - PEONIES

- CLASS 3 UNLIMITED VARIETIES, 1 TO A VASE, LIMITED TO 3 VASES OF 1 VARIETY.
CLASS 4 VASE OF 6, 1 VARIETY OR MIXED, 3 VASE LIMIT.

SECTION C - HYBRID TEA ROSES

- CLASS 5 VASE OF 1 BLOOM, LIMITED TO 3 VASES OF 1 VARIETY.
CLASS 6 VASE OF 3 BLOOMS, 1 VARIETY, LIMITED TO 3 VASES OF 1 VARIETY.

SECTION D - FLORIBUNDA ROSES

- CLASS 7 VASE OF 1 STEM, LIMITED TO 3 VASES OF 1 VARIETY.
CLASS 8 VASE OF 3 STEMS, ONE VARIETY, LIMITED TO 3 VASES OF 1 VARIETY.

SECTION E - GRANDIFLORA ROSES

- CLASS 9 VASE OF 1 STEM, LIMITED TO 3 VASES OF 1 VARIETY.
CLASS 10 VASE OF 3 STEMS, 1 VARIETY, LIMITED TO 3 VASES OF 1 VARIETY.

SECTION F - MINIATURE ROSES

- CLASS 11 VASE OF 1 STEM, LIMITED TO 3 VASES OF 1 VARIETY.
CLASS 12 VASE OF 3 STEMS, 1 VARIETY, LIMITED TO 3 VASES OF 1 VARIETY.

SECTION G - CLIMBING ROSES

- CLASS 13 VASE OF 1 STEM, LIMITED TO 3 VASES OF
